

September 14, 2019 TOURNAMENT RULES

Tournament rules: Will be interpreted by tournament directors and all decisions are final.

Alcoholic: Beverages are prohibited during tournament hours.

Liability Insurance: Current watercraft liability insurance is required.

Boats and Motors: All boats must be 15 feet or larger and a minimum of 15 hp motor, a working aerated live well and working engine kill switch.

Safety and Sportsmanship: All Missouri State Water Patrol and Department of Conservation regulation apply. Life jackets must be worn anytime main engine is running with kill switch lanyard attached.

Eligibility: Appropriate fees and all contestants must be 16 years of age or older unless accompanied by parent/guardian and no more than two persons pre boat.

Entry Fee: \$150.00 per boat (optional Big Bass \$10.00 extra per boat) all fees payable by check, money order or cash and will be accepted up until take off time. Note: The completed entry form and payment must be submitted and received by the tournament committee before a boat number can be assigned.

Tournament Hours and Take Off: Saturday take off at 7:00 AM, weigh in at 3:00 PM. All fish must be caught during tournament hours. Take off and weigh in at Alhonna Resort at the 8 mile marker of the Lake of The Ozarks. Boat position will be determined by order of entry fees. Take offs may be delayed by tournament director due to poor weather conditions.

Tackle and Equipment: Only artificial bait or lures may be used, no trolling and only rod and reel are permitted. Pork style baits are allowed, No Alabama Rigging.

Permitted Fishing Locations: Anywhere on the tournament lake except; inside the buoys of any public launch areas, within 50 yards of another boat, commercial boat docks or within the tournament take off cove.

Scoring: 5 fish per team; Largemouth, Kentucky or Spotted and Smallmouth Bass 15 inch in length will be counted for total stringer weight per team and will determine finish place. Any short bass presented for weight-in will cause a loss of 2 pounds (per fish) to be subtracted from total weight and loss of short fish. Late check in penalty 1 lb per minute up to 10 minutes then disqualification. Dead fish will be penalized 1 pound per fish up to two fish over two fish automatic disqualification.

Protests: Must be filed in writing within 15 minutes after weigh in.

Ties: Ties will be broken by earliest starting position.

Tournament Cancellation: If the tournament is completely canceled due to reasons of safety, entry fees will be refunded, no refunds will be made for any other reason. In case the tournament is partially delayed or shortened for safety reasons the decisions of the tournament officials will be final.

The Tournament Director Reserves: The Right To Refuse Or Reject Any Application Or Participants and Polygraph Test May Be Given at Tournament Directors Discretion.
